What's New in Formulas Online 1.2 (Industry Members)

September 8, 2012

The following system updates and new functionality are included in Version 1.2 of the Formulas Online system:

- **Browser Compatibility Updates** – You may now submit submissions in the Formulas Online system through the Firefox, Safari, and Chrome web browsers with no issue. However, it is still recommended you utilize the Internet Explorer web browser for the best performance.
- **Cancellation of Daily System Maintenance** – The Formulas Online system is no longer unavailable daily from 10 a.m. ET to 10:15 a.m. ET for system maintenance. This daily system maintenance has been cancelled and you no longer need to save your work-in-progress and log off Formulas Online before this time period.

Beginning on **April 24, 2012**, Formulas Online will be unavailable **daily** from **10 a.m. ET to 10:15 a.m. ET** for system maintenance. Opening links in new tabs will display information concurrently, allowing you to toggle back and forth between the tabs and view/review information within them.
