INSTRUCTIONS

You must complete this form in order to receive a user ID and password to obtain access to TTB's COLAs Online System. Each user must obtain an individual user ID and password which is not to be shared with anyone. Sharing your user ID and password can result in cancellation of your COLAs Online privileges.

Section A – You must check the appropriate box:

(1) Check *New User* if you want access to COLAs Online for the first time.

(2) Check *Modify User* if you want to change any of the information you originally supplied in Section B or C. In all cases, supply your User ID (Section A, Item 2) and complete only those items in Section B and C that have changed.

For changes to Section C: (i) You must notify TTB's National Revenue Center in Cincinnati, OH of any changes to your company name, address, or registry/permit/brewer's notice numbers before making any changes in COLAs Online; and (ii) If you are deleting a registry/permit/brewer's notice number, indicate in Section C, Item 17 which number(s) you want deleted from COLAs Online.

(3) Check *Delete User* if you no longer want access to COLAs Online for yourself or another user. Please provide the User ID of the user to be deleted, if known (Section A, Item 2).

(4) Check *Reactivate User* if we cancelled your original User ID due to inactivity and you wish to begin using the COLAs Online system again. You must also complete the remainder of the form as instructed below and include your previous user ID.

Section B - You must enter the required information about the individual requesting access to COLAs Online in items 3 - 15. Item 11 should only be completed by third party filers (e.g. trade associations, law firms, consultants). Third party filers who have not previously been assigned a Rep ID number must request one from ALFD at 1-866-927-2533, before submitting this form.

Section C - You must enter the required information about the company for which you are requesting to file applications. This information must appear exactly as it does on the Registry, Permit or Brewer's Notice. Be sure to enter the correct number in item 17 (example: BW-PA-00, PA-I-00, DSP-PA-00, BR-PA-AAA). If you are filing for multiple Registry/Permit/Brewer's Notice Number, you may include a list of them on a separate sheet attached to this form. The attached list must include the company name and address, Registry, Permit or Brewer's Notice Number and approval signature by a company official with signing authority for each permit for which you are requesting access. Any person without signature authority must also attach a separate TTB F 5000.8, Power of Attorney, for each company on behalf of which they will be filing label applications.

Your user ID will be sent to you via e-mail and your password will be provided separately via telephone for security reasons.

PRIVACY ACT INFORMATION

We provide this information to comply with Section 3 of the Privacy Act of 1974 (5 U.S.C. 552a(e)(3)).

We require this information under the authority of 27 U.S.C. 205(e). You must disclose this information so we identify the company on whose behalf applicant claims to act, to verify the scope of the applicant's authority to act, and to evaluate the applicant's qualifications for access to the system.

We use this information to approve, grant and control access to sensitive information systems. In addition, the information may be disclosed to other Federal, State and local law enforcement and regulatory agency personnel to verify information on the application and to aid in the performance of their duties. The information may further be disclosed to the Justice Department if it appears that the furnishing of false information may contribute to a violation of Federal law. PAPERWORK REDUCTION ACT NOTICE

This request is in accordance with the Paperwork Reduction Act of 1995. We use this information to authenticate end users in the program to electronically file Certificates of Label Approval. The information is used by the Government to verify the identity of the end users prior to issuing them passwords.
