- 3) Failure of payment of tax by return TTB F 5000.24 with remittance under 26 U.S.C. 5041 & 27 CFR § 24.271.
- 4) Failure to complete and submit TTB F 5120.17 Report of Bonded Wine Premise Operations under 26 U.S.C 5367 & 27 CFR § 24.300 (g).
- 5) Failure to prepare physical inventory record under 26 U.S.C 5369 & 27 CFR § 24.313.

BUSINESS IN WHICH ENGAGED:
 The proponent is a duly qualified bonded winery.

 The alleged violations commenced on or about July 1, 2014 and continued through July 31, 2019 at the proponent's premises located at 644 Hanna Drive, Suite B, American Canyon, CA 94503.
