Legend

- 1) **Size - Based on Annual Production** - The listed strata of breweries is based on the total amount of beer, in barrels, produced during the calendar year by each brewer.
- 2) **Number of Breweries** - Count of brewery premises reporting production operations and paying taxes during the calendar year, from TTB data records.
- 3) **Barrels Produced** - Total barrels of beer produced by the breweries comprising the named strata of data. Totals from each brewer are drawn from Lines 2 and 3, column (g), of TTB Form 5130.9 - Brewer's Report of Operations, and Line 2 of TTB Form 5130.26 - Quarterly Brewer's Report of Operations submitted by brewer's for operations during the calendar year.
- 4) **Taxable Removals** - Total barrels removed subject to tax by the breweries comprising the named strata of data. Totals from each brewer are from Lines 14 and 15, column (g) of TTB Form 5130.9 - Brewer's Report of Operations, less the totals from Line 7, column (g), (returns of this breweries' beer to the brewery during the reporting period), plus Lines 10 and 11 of TTB Form 5130.26 - Quarterly Brewer's Report of Operations submitted by breweries for operations during the calendar year, less the amounts on Line 4 (returns of this breweries' beer to the brewery).
- 5) **Barrels Shipped (or Exported)** - Total barrels of beer removed from brewery without payment of tax for direct export.
