IMPORTER OF TOBACCO PRODUCTS INFORMATION

As requested, we are enclosing the necessary forms for your use in applying for a permit to import into the United States tobacco products, which were manufactured in a foreign country, Puerto Rico or the Virgin Islands.

Please be sure to provide an Email address, when you submit your paperwork, for contact purposes. This will enable us to notify you when we receive your application and possibly process your paperwork more quickly.

TTB Form 5230.4, Application for Permit Under 26 U.S.C. Chapter 52 Importer of Tobacco Products, must be completed following the instructions on the form.

If someone will be signing the application and/or supporting documents or act on your behalf in matters pertaining to TTB, you must submit one of the following with your application:

- TTB F 5100.1, Signing Authority for Corporate and LLC Officials. This may be granted by title rather than individual name;
- TTB F 5000.8, Power of Attorney; or
- Corporate resolution or specific notification in the organizational documents granting that authority.

If you are filing as a corporation, you must also file the following:

- Copy of Articles of Incorporation
- Copy of Bylaws, and
- Certificate of incorporation which has been executed by an officer of the state in which incorporated

If you are filing as a limited liability company, you must also file:

- Copy of Articles of Organization
- Copy of Operating Agreement, and
- Certificate of organization which has been filed with the state in which organized

If you are filing as a partnership, you must also file a copy of the Partnership Agreement. If there is a verbal agreement rather than written partnership agreement, please provide a statement to that effect signed by all partners. If no single partner has signing authority on behalf of the partnership, all partners must sign each form sent to this office.

If the premises to be used for this operation are eligible for the National Register of Historic Places, you should not begin construction or remodeling until you have contacted the State Historic Preservation Office (see enclosed information).

The tobacco regulations can be found on our website www.ttb.gov. Select the tab Regulations & Guidance, then Regulations from the dropdown selections, and finally select Part 41, Importation of Tobacco Products, Cigarette Papers and Tubes, and Processed Tobacco.
