Special (Occupational) Tax for tobacco occupations has NOT been repealed, and registration and payment requirements remain in effect. All manufacturers of tobacco products, manufacturers of cigarette papers and tubes, and export warehouse proprietors must file <a href="https://doi.org/10.1016/j.com/not/10.1016/j.com/

Use <u>TTB F 5630.5t</u> to register and pay liabilities incurred on tobacco occupations, for all years.
