Getting Tax Relief

If your operations have been affected by a natural disaster and you're having trouble paying the taxes you owe, or if you're not able to pay by the deadline, we have several options that can help.

Installment Agreement

Pay off your outstanding tax liability (including penalties and interest) in full over time.

Extension of Time for Paying Tax

Apply for an extension if you would experience undue hardship by paying on the due date.

Waiver or Abatement of Penalties

Qualify for relief from penalties if you were unable to meet your tax obligations due to circumstances beyond your control.

Offer in Compromise

Settle your tax debt for less than the full amount if you can establish an inability to pay in full, or if you believe you do not owe the tax in question.

Food and Drug Administration Notice

The U.S. Food and Drug Administration (FDA) offers guidance about the safety of foods, including alcohol beverage products, adversely affected by hurricanes, flooding, and power outages. The FDA notice states that food products submerged in flood waters may pose a health hazard because of possible exposure to sewage, chemicals, heavy metals, pathogenic microorganisms, or other contaminants. The notice advises that certain food products that have been exposed to flood waters are adulterated and should not enter the human food supply.

Qualifying for a Waiver

A natural disaster may impact a business's ability to timely file returns and pay or deposit federal excise taxes administered by TTB. Based on these circumstances, TTB may waive late filing, payment, or deposit penalties.

To qualify for a waiver, a taxpayer must contact the National Revenue Center and demonstrate that their inability to timely file, pay, or deposit was due to reasonable cause and not to willful neglect. In making its determination, TTB will consider all factors, including any effects of the natural disaster.

Filing a Claim

Businesses may file claims with TTB for the payment (refund or allowance of credit) of federal excise taxes paid on beverage alcohol or tobacco products lost, rendered unmarketable, or condemned by a duly authorized official under various circumstances, including where the President has declared a major disaster. Claims are subject to a number of conditions, including:

- Timeframe
- Theft
