Pursuant to our telephone conversations, this letter is to confirm the fact that we are very definitely interested in pursuing both petitions proposing the establishment of an "Arkansas Mountain" viticultural area and an "Ozark Mountain" viticultural area.

We have discussed this with other winegrowers at various Wine And Grower meetings and the general concensus is that there is much greater interest in the "'Arkansas Mountain" viticultural area.

We were told by personnel on your staff to submit our application anyway even though we didn't have the precise data on the distinguishing geographic features perfected. They suggested we get our application in and amend it when we have the detailed information needed. Viticulturists and Enologists at the University of Arkansas are assisting us with the acquistion of data to supplement and/or amend petitions.

My personal hospitalization for surgery on a ruptured disc and the loss of Mr. Scott Phillips (who had to go back to help his family in Florida) who was pursuing this, has caused a delay that could not be foreseen. I'm recovering very painfully but positively for the better, and will forward the appropriate material very shortly.

In reference to Notice 466 about the proposed "Altus" viticultural area, we hereby voice our opposition to the deletion of some of our local vineyards from the proposed area and would like to be heard on the matter.
