We have used grapes from the Dundee Hills since our first vintage at Rex Hill Winery in 1983. Many of the wines made from those grapes have been designated by the name of the single vineyards in which the grapes were grown, and more recently we have produced a Dundee Hills Cuvee which is a blend from several of the vineyards. One of those single vineyard wines, from the 1988 vintage, was selected as the top Pinot Noir in the world at the prestigious International Wine and Spirits Competition in London in 1991.


Over the twenty years since 1983 we have owned vineyards in the Dundee Hills and currently lease two other vineyards in the proposed AVA from their family owners. Although we have produced many single vineyard Pinot Noirs from grapes grown throughout the Northern Willamette Valley, those made from fruit grown in the Dundee Hills have consistently been among our very best. Those vineyards have allowed us to produce more special single vineyard wines from the Dundee Hills than from any of our other sites in the valley.

For ten of those years we also operated a hot air balloon from our winery which regularly flew over or around the Dundee Hills on its morning journeys. From the balloon we could not only appreciate the unique character of the Dundee Hills from the air, but we could also learn the pattern of the air currents which were dramatically affected by the horseshoe shape of the hills and watch as the clouds regularly were diverted to the north and the south by the westernmost ridge of the hills leaving the central and eastern slopes clear and dry.

From our perspective, the Dundee Hills is really the perfect example of what an AVA is supposed to be. The deep Jory soil which underlies almost all the proposed AVA gives the wines a very special character which simply can't be reproduced from any other vineyards and the unique geography creates a climate which differs from the rest of the Willamette Valley. It truly is a special place.

We strongly recommend adoption of the proposed Dundee Hills AVA.

As wine growers in the proposed Dundee Hills AVA, I am writing to support the approval of said proposal. It is our belief that the division of the Willamette Valley into more specific appellations will aid consumers when purchasing an unfamiliar brand of wine, and will help them to identify specific characteristics in the finisher product with wines from that particular region.

The area known fondly as "Dundee Hills" by local inhabitants and members of the wine industry is a region that is geographically distinct from its neighboring wine growing areas. Visitors to the area are apt to notice the red, rocky volcanic soils that comprise the footprint of this area. It is our belief that wines made from grapes grown on these distinctive soils reflect the area's unique climate and geography accordingly. In addition to volcanic soils, other distinctive features of the Dundee Hills include warmer nighttime temperatures, less frost, and less low-elevation fog than surrounding valleys. These geographic features result in fruit that ripens earlier and more consistently than that of growers in neighboring regions. Wines from Dundee Hills are characterized by sensuous, supple fruit flavors and slightly lower acid levels than those of our neighbors.
