I am writing in reference to the Federal Register Vol. 46, No. 150, Wednesday, August 5, 1980, Notice No. 380 which refers to the "Establishment of Leelanau Peninsula Viticultural Area."

I work as a Horticulturist for Michigan State University. I have been involved in research and extension in fruit crops in the Northwest lower peninsula area of Michigan for the past fifteen years. In 1979, the fruit industry established a horticultural research station near Traverse City and I have been director of the facility since that time. Therefore, I am very familiar with the proposed viticultural area.

I would concur with the petitioner that the area designated as "Leelanau Peninsula" is indeed a unique fruit growing area which has the proper climate, topography and soils for growing many fruit crops, including many varieties of grapes. The moderating effect of Lake Michigan delays fruit development in the spring generally beyond the most serious frost period and then prevents sudden drops in temperature in the fall. This area of Michigan also receives considerable winter snowfall which generally prevents the soil from freezing, thus preventing fruit tree and vine crop root injury. In fact, many fruit crops survive better in Northwest Michigan than in Southwest Michigan due to the protective snow cover.

As the author of <u>The Wines of America</u>, for the third (1973) edition of which I am currently engaged in field research in all winegrowing districts of North America, I have been invited by winegrowers in the Leelanau Peninsula of Michigan to comment to the Bureau upon their request for establishment of the Peninsula as a viticultural area.

Having studied the climatic differences among the principal viticultural districts of Michigan and having visited each of the wine-grape vineyards of the Peninsula, I am impressed by the evidence that the Peninsula is distinctly different in climate affecting wine grapes from the other areas where such grapes are grown in Michigan. I think the Bureau has the same logical reasons to establish the Leelanau Peninsula as a viticultural area that warranted the Bureau's actions in the cases of Augusta in Missouri, Fennville in Michigan, and for other examples, Santa Maria and San Pasqual Valleys in California.

Dear Director Dickerson:

The Association of American Vintners is an association comprised of vintners from 24 states representing the Eastern Wine Industry in volume of wine produced and leadership in improvement in the high quality of wine produced in the United States. Membership today stands at 94 wineries. The Association has presented testimony on a variety of topics to the Bureau in the past including a statement of opposition on the petition to establish a viticultural area named Shenandoah Valley in California.

The Association of American Vintners has a strong interest in the development of properly constituted and named viticultural areas as an aid to the consumer in the selection of fine wines readily identifiable by their characteristics imparted by climate and soil, and also as an aid to the wine marketer who may choose to identify his wine by the viticultural area in which it is produced as an extra guarantee of authenticity.

The Association of American Vintners opposed the petition for adoption of Shenandoah Valley Viticultural Area because of the preexistence of the well-known Shenandoah Valley of Virginia, a region of great historical and contemporary renown in no way similar either by reputation or climate to the valley of the same name in California.
