Re: Proposed McMinnville Viticultural Area (2002R-217P) Notice No. 12

Gentlemen:

My wife and I own a vineyard within the proposed viticulture boundaries as described in the above referenced notice. This vineyard was planted in the mid 1980's, and has produced a viable crop for many years. The criginal owner sold his grapes every year to a local winery for blending into that winery's product.

My wife and I purchased this vineyard in 1997, and have continued to have successful harvests every year. We have also expanded the vineyard to include a clone of pinot noir that will ripen earlier than others. Last year was the first year we had enough pinot grapes to harvest, and we have a delicious wine ageing in our barrels at this time.

Our elevation is 1200 feet above sea level.

I have records going back to 1999 that show that our degree-days are sufficient to riper our yearly crop. While it is true that our daily high temperatures may be less than those at a lower elevation, our nighttime temperatures are usually higher than those lower elevations during the growing season.

Degree-days are calculated on a twenty-four bour day basis, so a higher nighttime temperature lends

itself to a higher degree-day calculation. Our daily mean temperature can be as high as lower elevations because of this reason.

My wife and I are also the owners of Stone Wolf Vineyards, with a vineyard in the Eola Hills region and a winery in McMinnville. We are quite experienced in what it takes to successfully grow good grapes and produce a quality wine. We have invested heavily in land and the development of vineyards in both areas (Eola Hills and McMianville) and do not think it fair or reasonable for someone to suddenly decide that we are not viable growers/producers just because of our altitude. If a winery cannot grow good grapes and produce a great wine, the laws of economics tells me that they will not have a successful operation for long, regardless of elevation.

We are quite aware of the benefit of the proposed viticultural area, and have urged the McMinnville city leaders to take advantage of the boom in wineries in the area to boost tourism. However, we feel that to limit the area to specific altitudes is to limit the number of quality producers that have strived to grow and produce wines of distinction. We strongly protest the proposal as written if it continues to have specific restrictions on attitude.

Comments=Re: Proposed McMinnville AVA (2002R-217P Notice 12)

As petitioner for this proposed AVA, I have researched information provided by Mr. Art Lindsay of Mystic Mountain Vineyards with respect to the exclusion of any sites higher than 800'.

Based on my investigation, it is clear that Mr. Lindsay's data is correct. Within the proposed boundaries of the AVA, higher elevation sites do report lower day time temperatures but substantially higher night time temperatures. As a result, growing degree days calculated for the 24 hour period are comparable to sites at lower elevations. As well, one must give weight to the significant history of quality grape growing that Mr. Lindsay's vineyard has shown.

As a result of this information, the petitioner would request that the 800' elevation exclusion be eliminated from the proposed boundary criteria (except where it defines the outside most boundary of the AVA).
