ALLEGED VIOLATIONS:

On or around and between December 12 - December 16, 2006 and January 7 - January 12, 2008, Pur Vine LLC. produced wine without a permit, allegedly in violation of Title 26, U.S.C. Section 5043 (a)(3), and other related violations. Other pertinent alleged statutory violations or sanction statutes are as follows: 26 U.S.C. 5041, 5043, 5351, 5354, 5367, 5661 (b), and 27 U.S.C. 203 and 207.

BUSINESS IN WHICH ENGAGED:
The proponent engaged in business as a winery without obtaining a basic permit.

DATE OR PERIOD AND LOCATION OF ALLEGED VIOLATIONS:
On or about and between December 12 - December 16, 2006 and January 7 - January 12, 2008, at 425 S. 48th Street, Suite 108, Tempe, Arizona.

AMOUNT AND TERMS OF OFFER:
The proponent has submitted an offer of \$7,500.00 in compromise of the above violations incurred under the Internal Revenue Code and the Federal Alcohol Administration Act.

RECOMMENDATIONS:
The Director, National Revenue Center recommends acceptance of the offer. In view of potential litigation hazards, acceptance of this Offer in Compromise, as submitted, is warranted.
