INITIAL DECISION

On March 8, 2019, the Alcohol and Tobacco Tax and Trade Bureau (TTB) issued an Order to Show Cause (OTSC) why TTB should not suspend bonded winery basic permit number CA-W-1128, held by Monticello Cellars, Inc. (Monticello), due to alleged violations of the conditions of such permit as set forth in the OTSC. Monticello received the OTSC on March 20, 2019. The OTSC was accompanied by a letter informing Monticello that it had 15 days from the date of service to request a hearing or file a written answer and, that if it did not respond within 15 days, TTB would issue an order suspending Monticello's permit. Monticello has not responded to the OTSC and the period for Monticello to request a hearing or file a written answer has expired. Accordingly, under the authority of 27 C.F.R. § 71.79(b), TTB's Deputy Assistant Administrator (Field Operations) hereby issues this Initial Decision.

The Federal Alcohol Administration (FAA) Act, under which Monticello's permit was issued, provides in pertinent part that a bonded winery's basic permit shall, after due notice and opportunity for a hearing to the permittee, be suspended for such period as the Secretary of the Treasury deems appropriate, if the Secretary finds that the permittee has willfully violated any of the conditions thereof. 27 U.S.C. § 204(e)(1).

FINDINGS OF FACT AND CONCLUSIONS

1.	Monticello is a bonded winery operating in California (and an "industry member" within the meaning of 27 C.F.R. §§ 11.11, 11.21).
2.	is a TTB-permitted wine wholesaler located in (and a "trade buyer" within the meaning of 27 U.S.C. § 205(d) and 27 C.F.R. §§ 11.11, 11.21).
3.	An FAA Act basic permit is conditioned upon compliance with the requirements of 27 U.S.C. § 205 and all other federal laws relating to distilled spirits, wine, and malt beverages, including taxes with respect thereto. 27 U.S.C. § 204(d).
4.	Section 205(d), makes it unlawful for an industry member to sell, offer for sale, or contract to sell to any trade buyer on consignment.
5.	Federal regulations define "consignment sales" as arrangements wherein the trade buyer is under no obligation to pay for distilled spirits, wine, or malt beverages until they are sold by the trade buyer. 27 C.F.R. § 11.22.
6.	In or around March 2016, and continuing through approximately March 2018, Monticello sold wine to pursuant to an arrangement whereby was not obligated to pay for the wine until after it sold such wine to retailers.
7.	Monticello voluntarily entered into these sales arrangements with .
8.	The trade buyers took possession of Monticello's wines, after arranging for the wines to be transported in interstate commerce to their storage facilities outside of California.
9.	Purchase orders generated by reflected a \$0 amount as the cost per order.
10.	Christopher Corley, owner of Monticello, and Chris Towns, Monticello bookkeeper, stated to TTB investigators that paid Monticello for the wine after selling the wine to retailers.
11.	Monticello acted willfully, or with plain indifference to the requirements of the FAA Act, in entering into the consignment sale arrangements with
12.	Monticello, by willfully engaging in unlawful consignment sales, violated the conditions of its permit and subjected its permit to suspension.

- 13. Monticello received service of TTB's OTSC on March 20, 2019.
- 14. Monticello was afforded due notice and opportunity for hearing.

- 15. Monticello failed to file an answer or request a hearing within 15 days of the service of the OTSC and has waived its right to a hearing and its right to contest the grounds for the action.
- 16. The findings in the foregoing paragraphs of this section provide a sufficient basis upon which to suspend Monticello's permit.
- 17. Monticello's authority to operate as an FAA Act bonded winery basic permittee may and should be suspended for a period of one day.

DECISION AND ORDER

For the foregoing reasons, Monticello's authority to operate as a bonded winery is hereby suspended for one day. Monticello shall serve its suspension on Friday, June 21, 2019.
