**VIOLATIONS:** The proponent allegedly failed to pay some federal excise tax liability in violation of 26 U.S.C. § 5061 and 27 C.F.R. § 19.239 for some periods between April 1, 2014 and November 30, 2017.

**BUSINESS IN WHICH ENGAGED:**  
The proponent is a duly qualified bonded Distilled Spirits Plant operator.

**DATE OR PERIOD AND LOCATION OF VIOLATIONS:**  
The alleged violations occurred for some of the periods between April 1, 2014 to November 30, 2017 at the proponent's premises located at 312 E. Main St., Ennis MT 59729.

**AMOUNT AND TERMS OF OFFER:**  
The proponent has submitted an offer of \$300,000.00 in compromise of tax liability incurred under the Internal Revenue Code. The terms of the offer are the following: an initial payment of \$4,000; semimonthly payments of \$4,000 for 11 months, \$5,000 for 12 months, and \$6,000 for 5 months; and one payment of \$28,000 for the remaining balance.

**RECOMMENDATIONS:**  
The Director, National Revenue Center, recommends acceptance of the offer. The proponent listed doubt as to collectibility and provided supporting financial documentation. The acceptance of the Offer-In-Compromise, as submitted, is warranted.

9. I have considered the proposition to compromise the liability as charged herein, and, for the reasons embodied in the above abstract and statement, am of the opinion that it will be for the best interest of the United States to  ACCEPT  REJECT the terms proposed.
