- I. Item 5. What is a trade name? In general, a trade name is used to identify your business that is not its legal name. Business operations include any name with which you identify your business on invoices or letterhead. Also, business operations include a name that identifies your business on packages of tobacco products or cigarette papers and tubes.
- J. **Item 5. Am I required to have a trade name certificate?** Your State, county, or municipal authority may require a trade name certificate to operate your business under a trade name. If your State, county, or municipal authority does not require a trade name certificate, state this fact in item 5c.

- O. When can I expect my permit? In general, it takes from 2 to 12 weeks before TTB decides on amending your permit. TTB thoroughly examines the information that you provide with this application. If you omit information or provide partial information, it will take longer. Also, TTB may request additional information based on the information that you have provided. If TTB decides not to issue the amended permit, you will receive a written notice stating the reasons.
