**BUSINESS IN WHICH ENGAGED:**  
Workhorse Brewing Company, Inc, ("Proponent") operates a brewery.

**VIOLATIONS:**  
TTB alleges that Proponent failed to report the change in proprietorship resulting from a conversion from a LLC to a C-Corporation in violation of 26 U.S.C. §5401(a) and 27 C.F.R. §25.72.  
TTB alleges that Proponent failed to remit Federal Excise Tax on beer removed for consumption or sale in violation of 26 U.S.C. §5051; 27 C.F.R. §25.153.  
TTB alleges that Proponent failed to file Federal Excise Tax Returns on Federal Excise Tax incurred on beer removed for consumption in violation of 26 U.S.C. §5061; 27 C.F.R. §25.164(a).  
TTB alleges that Proponent failed to timely file Federal Excise Tax Returns and timely pay Federal Excise Taxes, thus, subjected to penalties and interest under 26 U.S.C. §§ 6651(a)(1), 6651(a)(2), and 6601.

**DATE OR PERIOD AND LOCATION OF VIOLATIONS:**  
The alleged violations occurred between the periods below at Proponent's premises located at 250 King Manor Drive, King of Prussia, PA 19406.

**AMOUNT AND TERMS OF OFFER::**  
Proponent has submitted an Offer-in-Compromise in the amount of \$20,000, and has remitted the entirety of this amount.

**RECOMMENDATIONS:**  
The Deputy Director of Tax Services Division, Office of Permitting and Taxation, believes Proponent has averred sufficient facts to establish doubt as to liability and believes the amount being offered is commensurate with expected litigation risks. As such, the Deputy Director recommends acceptance of the offer.
